#### Objectives and Investment policy

##### Objectives and Investment Policy

At the ICAM FIRST Sub-Fund we aim at providing medium to long term capital growth in euro.

To achieve this goal, we aim to profit mainly from increasing stock, fixed income (including the possibility to invest in high yield bonds) and money market instruments prices. Our focus is on both equity and bonds on the OECD markets, with a focus on the European and United States markets. As a result, the performance of the Sub-Fund depends on such securities. The Sub-Fund may invest in other funds (including ETF).

We will never make use of financial derivative instruments, unless for the purpose of preventing the currency risk.

##### Recommendation


You will not receive any dividend from the Sub-Fund. Dividends received by the Sub-Fund will be reinvested.

You can redeem your shares daily during Luxembourg business days, before (cut-off) 17:00 pm (Luxembourg time).

As an investor, you must have a medium term investment horizon with a high risk profile.

Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within 3 years. You must also assume the risk of receiving a lower amount than your original investment.

#### Risk and reward profile



Given the lack of historical data available on the share of the Sub-Fund, launched on February 27<sup>th</sup> 2015 (less than 5 years), the above indicator has been calculated on a standard asset selection that we would have adopted at the time when the indicator has been computed.

Stock funds are more volatile than bond funds. Due to the fact the Sub-Fund invest in mix of both asset classes without any restriction in terms of weight on a specific one, the risk indicator is consequently high.

However, the risk category shown is not guaranteed and may shift over time while the lowest category does not mean "risk free". Also you must be aware that historical data is not a reliable indication of the future risk profile of the Sub-fund.

Please note the following risks are materially relevant to the Sub-Fund and are not adequately captured by the indicator:

- Discretionary risk: the discretionary management

method applied to the Fund relies on stock and bond selection. There is a risk that at any given time the Sub-Fund may not be invested in the highest performance securities. The Sub-Fund's net asset value may also decline.

- Counterparty risk: the insolvency of any institutions providing services such as safekeeping of assets or other instruments may expose the Sub-Fund to financial loss.
- Operational risk: failures or delays in operational processes may negatively affect the Sub-Fund.
- Liquidity risk: lower liquidity means there are insufficient buyers or sellers to allow the Sub-Fund to sell or buy investments readily.


The entry and exit charges indicated are maximum amounts. The percentages may be lower or null in various cases. You should ask your financial advisor regarding the application of the entry and exit charges.
